We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

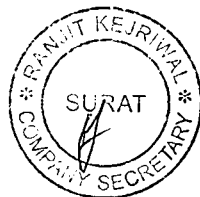
I have examined the records of **M/s Arnold Holding Limited** ("the Company") which comprises:
